Pole Vault: Patrick Georgia

Patrick Georgia brings over 30 years of pole vault experience as he begins his 9th season as an SNC coach. He has mentored the Green Knight vaulters with great success as 3 of the 4 school records in the pole vault are Georgia-coached athletes. Georgia was a standout vaulter for St. Norbert and finished his career atop the Midwest Conference standings!

Long/Triple Jump: Brandon Schlotthauer

Brandon Schlotthauer is entering his second season with the Green Knights. Last year, the SNC jumpers scored the most points of any MWC team in the Long Jump, with 2 athletes provisionally qualifying for the NCAA Championships.

Throws: Kelsey Marsh

Kelsey Marsh is entering her 2nd season in 2012. A former Green Knight competitor, Kelsey was one of the top SNC throwers during her four year career. Last season she had 2 athletes break school records and finish atop the podium at the conference meet.

Sprints: Dann Schneider

Dann Schneider is no stranger to Green Knight Track & Field having just capped off a standout career at St. Norbert. He is the school record holder in the 100, 200 and Long Jump and is a three-time All American in the 400m dash!

Don Augustine enters his ninth year working as a collegiate level head coach, during which he has had athletes break and re-break over



60 school records, set conference meet records 10 times and qualify for the NCAA National Championships every season since 2004 Augustine has coached 3 consecutive NCAA National Champions in the 800m run and has had an All-American in Cross Country, the 5K, and the 10K in 6 straight post-season Championship meets. In 2009, Augustine brought SNC to its highest Indoor and Outdoor National finishes, putting the Green Knight Ladies 8th Indoors and 10th at Outdoors. Augustine was a standout middle distance runner in college and twice earned All-Conference Academic honors at the Division II level.



SESSION INFORMATION

The St. Norbert Track & Field Camp will be held in the Schuldes Athletic Center Gymnasium on Saturday, January 7th. Athletes (Grades 7 - 12) have the option of choosing from two different session times. Session I runs from 12:00-2:30 P.M., while Session II is 3:00-5:30 P.M.

In order to ensure a high level of personal attention, registration spots are limited by event.



Athletes can register for both sessions in different events, but will be responsible for paying for each session separately.

The cost of the track & field camp is \$35(per session) and the registration deadline is January 4th. Registration on the day of camp cannot be guaranteed and the cost will be \$45.
