The Program emphasizes theory into practice. Having experiences in schools threaded throughout the program and associated with most classes allows the students to take what they are learning in the classroom and put it into practice immediately in a classroom. Making these connections provides experiences to see theory at work. In addition, course content in several courses has been adjusted to include at least some instruction in working with limited English proficient students. These include several literacy courses and our multicultural education course. All course-based field experiences also require formal, written reflection by each candidate.

St. Norbert College embraces digital literacy for all students as a critical skill set. The college is using the Bryn Mawr Digital Competencies Framework (<https://www.brynmawr.edu/digitalcompetencies/what-are-digital-competencies>) to help guide students skill development. Faculty modeling of effective teaching with technology is one way that knowledge and skills are developed in our pre-service teachers. SNC's Commons for Full Spectrum Learning created a framework which emphasizes the value of diverse approaches to teaching with technology that facilitate student engagement, see Full Spectrum Learning (<https://fullspectrumlearning.knight.domains>). Within this setting, the Education program incorporates a range of technologies in courses. Because the nature of technology is changing at a rapid pace, the education discipline inserted a "thread" throughout the program which incorporates skills particularly relevant to teaching. These skills are guided by the ISTE standards for teachers and tied to the Wisconsin Teacher Standards. Thus, specific courses require the use of particular technologies in assignments to build pre-service teachers' proficiencies. Summative assessment of these skills take place in student teaching and through edTPA.

From the first course in the program to the last, and throughout the pre-clinical and clinical experiences, we emphasize “meeting students where they are.” Consequently, understanding the nature and needs of students then designing instructional strategies to meet those needs is central. The program addresses the specifics as part of our “sophomore block” in EDUC 281 Teaching Children with Exceptionalities which focuses on introduction of basic terminology, themes, categories of disability, and general classroom practices and procedures that provide a basis for practice centering on inclusive education and differentiated instruction.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Pre-service teachers often encounter opportunities to work with individual education program teams in pre-clinical placements but usually have that experience in one or both of their clinical placements.

In August of 2018, the state of Wisconsin implemented a new version of PI34, the law governing teacher certification in the state. The law includes significant changes to the requirements for teacher preparation programs, including expansion of grade levels covered by various certifications, shifts in content requirements for elementary certification, consolidation of secondary licenses, and new options to support internships and residency programs. St. Norbert College Education program is incorporating these changes as we redesign preparation programs under the framework of the new law. The program is combining our strategic goals with the shifting elements of the law to create expanded opportunities and deeper preparation for our pre-service teachers. The program's progress to achieving these goals, and compliance with Wisconsin Department of Public Instruction regulations, is validated each year through an assessment conducted by our WDPI liaison. The Continuous Review Process includes sharing our program data, writing a "self study" report on the program's progress towards our goals, and a one-day site visit. We recently completed our 2020 CRP process and earned continued endorsement from the state of our capacity to certify teachers.
