



## Instructions to Obtain Acceptable Verification of Tax Information

**Tax Return Filers choose ONE of the following:**

### **IRS Data Retrieval Tool (DRT):**

The best way to verify income is by using the IRS Data Retrieval Tool (DRT) that is part of FAFSA on the Web. Go to **FAFSA.gov**. Log in to the student's FAFSA record with student FSA ID and password. Click on the correct aid year, then select "**Make FAFSA Corrections**", the second bullet point under "You can also:" Click on the **Financial Information** tab. Answer the questions to determine if you are eligible to use the IRS DRT. Click on "LINK TO IRS". This will bring you to the IRS website. Enter the address on file with the IRS (normally this will be the address used when the 2018 IRS tax return was filed), your filing status and click "submit" at the bottom of the page. This will take you to your tax information. Check the box that says "**Transfer My Tax Information into the FAFSA**" and select "**Transfer Now**". You will be redirected back to the FAFSA. Scroll down the page clicking "Next" at the bottom. Once you get to the "Sign & Submit" tab, you will need to **sign** (using your FSA ID) and **submit** the corrected FAFSA.

### **IRS Tax Return Transcript Online:**

To obtain an IRS tax return transcript, go to **www.IRS.gov** and click on the "**Get Transcript for My Tax Records**" link under the "Tools" bar. This will take you to "Get Transcript". Click on "**Get Transcript ONLINE**". You will need to create an account initially by providing your name, email, the address on file with the IRS (normally this will be the address used when the 2018 IRS tax return was filed), SSN, and answering security questions. Click on the "**Higher Education/Student Aid**" button. The screen will suggest that you get a tax return transcript. You can click on the appropriate aid year that is hyperlinked and a PDF will open in the same screen. From there you may print your tax return transcript.

### **IRS Tax Return Transcript by Phone:**

If you do not have internet access, you may call **1-800-908-9946**. Make sure you order the "IRS tax return transcript" and not the "IRS tax account transcript." You will need your SSN, date of birth, and the address on file with the IRS (normally this will be the address used when the 2018 IRS tax return was filed).

### **IRS Tax Return Transcript by Mail:**

You may get a paper tax return transcript mailed to you by going to **www.IRS.gov** and click on the "**Get Transcript for My Tax Records**" link under the "Tools" bar. This will take you to "Get Transcript" click on "**Get Transcript by MAIL**". From there you will be asked to enter your SSN, date of birth and the address on file with the IRS (normally this will be the address used when the 2018 IRS tax return was filed).

### **IRS Federal 1040 Tax Return:**

You may provide a **signed** copy of your 2018 Federal 1040 Tax Return form and all submitted tax schedules (1-6). If completed by a tax preparer or tax professional, the Federal 1040 Tax Return form must include name and address of the preparer on the return, as well as the tax preparer's Social Security Number (SSN), Employer Identification Number (EIN), or Preparer Tax Identification Number (PTIN). ## **Non-Tax Filers:**

### **Verification of Non-Filing Letter**

You and/or your spouse are required to provide Verification of Non-Filing Letter from IRS that indicates a 2018 IRS income tax return was not filed with the IRS. You can request this by visiting the IRS website at [www.irs.gov/Individuals/Get-Transcript](http://www.irs.gov/Individuals/Get-Transcript). Please attach letter(s) from the IRS to this worksheet.

## **Important Notes:**

- If you and/or your spouse filed an amended IRS income tax return for tax year 2018 you must provide:
  - A **2018 IRS Tax Return Transcript** (that will only include information from the original tax return and does not have to be signed), or any other IRS tax transcript(s) that includes all of the income and tax information required to be verified; **or**
  - A signed copy of the 2018 IRS Form 1040X, "Amended U.S. Individual Income Tax Return," that was filed with the IRS.
- If you are married, and filed separate 2018 tax returns, 2018 IRS tax return transcripts or signed copies of the Federal 1040 Tax Return for 2018 must be submitted for both you and your spouse.
