### Getting Started

1. Go to **AssociatedBank.com**.

If your employer gave you a code to allow you to create your own account, choose **Setting up a New Account with Employer Code**. Be sure to have your employer code and Social Security number before you get started. Enter the employer code to start opening your account.

### Have an account but never logged in?

Choose **New User**. You'll need to enter your name, ZIP code and Social Security number to locate your account. You'll be prompted to create a username and password.

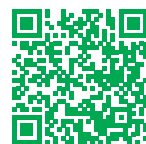
### Returning user?
