

Reporting options

- You may file both a college complaint and a criminal complaint.
- If you choose to file a complaint with the college, you may report the incident to a Title IX coordinator, deputy coordinator or Campus Safety.
- You also can file a complaint of discrimination with the Office for Civil Rights. Contact them at:

Supportive measures

Even if you don't make a formal report, the college can provide medical, academic and personal support, such as:

- Change in residence on campus
- Assistance with course assignments or enrollment
- Issuance of college no-contact/no-trespass orders

If you do not know whether the conduct you have experienced or witnessed constitutes sexual harassment, other gender-based misconduct or retaliation, you always are welcome to discuss the situation with the Title IX coordinator. In the event that the conduct does not fit into one of these categories, you will be referred to the appropriate office/individual who can further discuss and address the inappropriate conduct.

If you are in need of **medical care:**

The following hospitals may be accessed for medical care. In cases of sexual assault, victims are advised not to bathe, douche or change clothes before the exam. Sexual assault examinations are most successful within 72 hours.

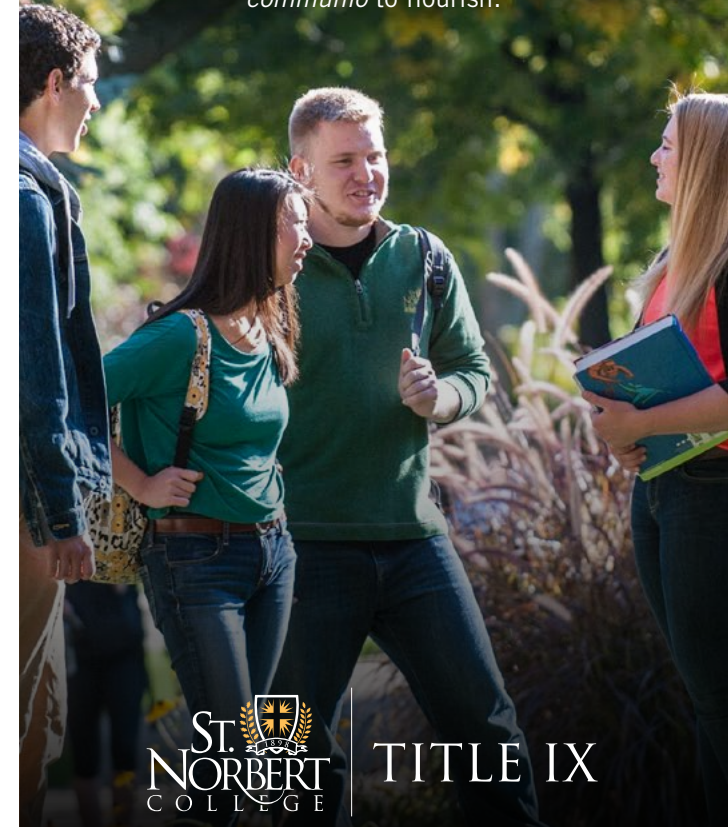

In an emergency, call 911. You also are encouraged (but are not required) to report the incident to one of the REPORTING RESOURCES listed. CONFIDENTIAL RESOURCES also are available to discuss options for reporting and campus and community resources.

St. Norbert College is committed to a safe and welcoming campus environment free of sexual harassment and other gender-based misconduct. We have developed policies and procedures to ensure students, faculty and staff have notice of behaviors that are prohibited and of ways to redress violations of this policy. This guide is designed to briefly outline the services available to those who have been harmed by sexual harassment and other gender-based misconduct.

Prohibited behaviors include sexual harassment, other gender-based misconduct and retaliation.

Sexual harassment, which includes the following:

- An employee of the college conditioning the provision of an aid, benefit or service of the college on an individual's participation in unwelcome sexual conduct (sometimes called quid pro quo harassment);
- Unwelcome conduct determined by a reasonable person to be so severe, pervasive and objectively offensive that it effectively denies a person equal access to the college's education program or activity; or
- Sexual assault, dating violence, domestic violence or stalking.

Other gender-based misconduct may include sex discrimination, nonconsensual sexual contact or intercourse, domestic or dating violence, stalking or sexual exploitation.

Retaliation, which includes actions taken against a person because they made a report/complaint of sexual harassment or gender-based misconduct, or were involved in the process as a respondent, witness or as part of the resolution process.

Reporting resources

Any individual who shares about an instance of sexual harassment or other gender-based misconduct to a reporting college resource can expect that the information will be handled with sensitivity and shared only with those individuals who have a need to know in order to respond. The identity of the individual(s) involved in reporting is gathered, but never publicly or openly shared. Consequently, reporting is private but not anonymous. When individuals seek confidentiality and anonymity, they should contact a confidential resource.

SNC Faculty, Staff and Student Workers

Note that all faculty, staff and student workers (except when listed as confidential resources) are **mandatory reporters**. This requirement applies to student workers only if they become aware of an incident while acting in their role as an employee. Students working for Campus Safety or as RAs are expected to be mandatory reporters at all times.

Confidential resources

These resources will keep your identity confidential, unless and until you give permission to disclose it. **When you call, specify that you want to speak to a confidential resource.**

Please note that even with confidential resources, there are reporting requirements that exist if there is an imminent threat to someone's safety or in the case of child abuse or neglect.
